ENTRY FORM, RULES & WAIVER

Contest Rules

1. Entry fee must be paid to compete \$3.00 by July 4th, by 1:45 pm.
2. All contestants must be registered and checked in by 1:45pm on day of contest.
3. Contestants at the Family 4th Fest must be between 5- 16 years of age – Entry form must be signed by parent or guardian. Kids will compete by age groups (age 5-8) (age 9-12) (age 13-16).
4. The object is to eat as many hot dogs AND buns, with water as the only beverage. Water will be provided.
5. Each contestant at Family 4th Fest will be given 5 hot dogs & buns, and the first to finish in their age group WINS!
6. Contestants will wait for the signal to start and a stopwatch will be used.
7. The allotted time is ten (10) minutes.
8. Dunking and crunching the hot dog and bun is allowed.
9. Separating the hot dog and bun to eat them individually is allowed.
10. Contestants must not touch any hot dogs or buns until the starting signal.
11. Any hot dog or bun in contestants mouth at the end of time will be counted – provided it is swallowed with in 1 minute.
12. Contestants must hold down the hot dogs and buns they have consumed for 2 minutes after the final signal.
13. Winner will be determined by whomever finishes the most hot dogs and buns within the allotted time.
14. The judges will determine the winner of the contest & the judges' decision will be final.
15. Any contestant caught breaking any of the above rules will be disqualified!
